November General Election will take place on November 5, 2024 from 7:00 A.M to 8:00 P.M.

<u>Wexford County Register of deeds</u> is now offering Fraud Notify, a FREE online subscription service That will notify you immediately via email if a document gets recorded under your name. This early warning system is helpful for owners to take action if they determine any fraudulent activity has taken place.

You can sign-up through this website: https://selfserve.wexfordcounty.org/web, Once you 've set up your username and password, you'll just need to verify your email address and then you'll be able to Add Alerts with either individual Names or Business Names.
